
**Subject – Inviting comments from stakeholders on the draft Recruitment Rules in respect of the CCW Engineering Cadre of Prasar Bharati – reg.**



G.S.R..... In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the All India Radio Chief Engineer (Civil) (Level II) Recruitment Rules, 1990 in so far as they relate to the post of Chief Engineer (Level-II), the All India Radio, Civil Construction Wing (Group 'A' & 'B' posts) Recruitment Rules, 1988 in so far as they relate to the posts of Superintending Surveyor of Works (Electrical)/ Superintending Engineer (Electrical), Superintending Surveyor of Works (Civil)/ Superintending Engineer (Civil), Executive Engineer (Electrical)/ Surveyor of Works (Electrical) and Executive Engineer (Civil)/ Surveyor of Works (Civil)/ Engineer Officer to Chief Engineer (Civil), except as respects things done or omitted to be done before such supersession, the Central Government, hereby makes the following rules regulating the method of recruitment to Group 'A' posts in the Civil Construction Wing of Prasar Bharati (Broadcasting Corporation of India) under the Ministry of Information and Broadcasting, namely:-

- (i) Short title and commencement. – (1) These rules may be called the Prasar Bharati, Civil Construction Wing (Group 'A') Recruitment Rules, 2026.
  - (ii) These rules shall come into force on the date of their publication in the official Gazette.
2. Application. – These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.
  3. Number of posts, classification and pay level in pay matrix. - The number of posts, its classification and pay level in the pay matrix relating thereto shall be as specified in columns (2) to (4) of the said Schedule.
  4. Method of recruitment, age limit, qualifications, etc. – The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in columns (5) to (13) of the aforesaid Schedule.
  5. Disqualification. – No Person, –
    - a. who has entered into or contracted a marriage with a person having a spouse living; or
    - b. who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:
- Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
6. Power to relax.- Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
  7. Savings. - Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex- Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
