Draft of RR's Group C

Ministry of Information & Broadcasting (New Media Wing) New Delhi, the 2021

- 1. Short title and commencement –(1) These rules may be called the New Media Wing(Group 'C' posts) Recruitments Rules 2021.
- 2. They shall come into force on the date of their publication in Official Gazette.
- 3. Method of recruitment age limit, qualification etc.-The method of recruitment, age limit, qualification and other matters relating to the said posts shall be as specialized in columns 6 to 14 of the aforesaid Schedule.
- 4. Disqualification-No person
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) who having a spouse living, has entered into or contracted a marriage with any person.

Shall be eligible for appointment to any of the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing exempt any person from the operation of this rule.

- 5. Power to relax-Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by order, for reasons to be recorded in writing and any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving-Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provide for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
