Subject: Cancellation of the LoI dated 31.03.2017 issued to M/s Rockstar EI Private Limited for establishing and providing FM Radio Broadcasting services (Phase III) at Mokokchung and forfeiture of NOTEF amount of ₹ 5,00,000/- reg.

Sir,


I am directed to refer to the subject mentioned above and to state that this Ministry vide letters dated 20.02.2019, 09.09.2019 and 13.12.2019 requested you to sign the Grant of Permission Agreement (GOPA) with the Ministry. After failing to sign the GOPA, the Ministry issued a Show Cause Notice (SCN) dated 30.07.2020, requesting you to explain why the Letter of Intent (LoI) dated 31.03.2017 issued to you for establishing and providing FM Radio Broadcasting services (Phase III) at **Mokokchung** should not be cancelled. You were further requested to explain why the Non-Refundable One-Time Entry Fee (NOTEF) of ₹5,00,000/-, deposited by you, should not be forfeited in terms of clause 7.5 of the Notice Inviting Applications (NIA) dated 20.06.2016.

2. Your attention is invited to clause 7.7.3 of NIA dated 20.06.2016, which stipulates that the timeline for the date of signing of Grant of Permission Agreement (GOPA) with this Ministry for Mokokchung station is 30.01.2018 (Ten months from date of issue of LoI) and the timeline for the operationalisation of this station is 30.03.2019 (24 months from date of issue of LoI). Both these timelines have since lapsed. You have neither signed the GOPA with the Ministry nor cared to even reply to the Ministry's letters and Notice stated in Paragraph 1 above.

3. Your attention is also invited to clause 7.5 of the aforesaid NIA which stipulates that in the event of failure of any LoI holder to sign the GOPA within the prescribed period, the full deposit of the bid amount shall be forfeited without further notice, and the LoI and the allocation of frequency, if any, shall stand cancelled.

4. Consequently, in view of the aforesaid provisions, the LoI dated 31.03.2017 issued to you is hereby cancelled and NOTEF amount of ₹5,00,000/- deposited with Government is also forfeited.
