#### **CIRCULAR**

Subject: Filling up one (1) post of Despatch Rider in Main Secretariat of the Ministry by Direct Recruitment - regarding.

The Ministry of I&B proposes to fill the post of Despatch Rider in Pay Matrix Level-2 (pre-revised Pay in PB-1 Rs. 5200-20200/- with Grade Pay of Rs. 1900/-) on Direct Recruitment basis in the Main Secretariat of the Ministry.

2. Eligibility conditions for selection as Despatch Rider are as under:

- 3. Age limit is 18-25 years. (Relaxable for Government servants up to the age of 40 years in accordance with the instructions or orders issued by the Central Governments). The crucial date for determining the age limit shall be the closing date for receipt of applications.
- 4. Selection of Despatch Rider shall be made on the basis of assessment of eligible candidates by the Departmental Promotion/ Selection Committee. The intimation will only be sent to the eligible candidates.
- 5. Application should be submitted as per the prescribed application form enclosed and should be signed by candidate along with the following documents:
  - I. Photocopies of the following certificates duly attested by Gazetted Offcer/ self attested:
    - a). Age Proof (Birth Certificate/ Xth certificate)
    - b). Educational qualification certificate

    - f). Knowledge of motorcycle or Auto-rickshaw certificate (if any)
    - g). One recent passport size photo should be pasted on the application form

Application without complete information or without requisite documents duly attested by Gazetted Officer/ Self attested will be rejected without any notice or information.
