Subject: Renewal of Grant of Permission Agreement (GOPA) to establish, maintain and operate Community Radio Station for the interim period up to 31.12.2016.

The undersigned is directed to intimate that this Ministry has decided, pending finalization of renewal policy and receipt of fresh security clearance, to renew Grant of Permission Agreement (GOPA) of those Community Radio Stations whose permissions have expired/expiring for an interim period up to 31.12.2016 or till the renewal of GOPA on regular basis based on receipt of fresh security clearance, whichever is earlier, from the date of expiry of previous GOPA, enabling them to continue their operations on the existing terms and conditions. The renewal of GOPA for the interim period will be subject to following:

- i) Receipt of security clearance from Ministry of Home Affairs.
- ii) The CRS permission holder will furnish Bank Guarantee of Rs.25, 000 having validity up to the interim period up to 31.12.2016.
- iii) The CRS permission holder shall submit an undertaking in the format enclosed.

2. All CR Stations whose validity of GOPA has expired or is expiring up to 31.12.2016 are requested to get their GOPA renewed and submit two original copies of GOPA in the prescribed format, an undertaking as mentioned in para-1(iii) above and a Bank Guarantee having validity for the period up to 31.12.2016. The format of GOPA for renewal and undertaking are also available on Ministries website www.mib.nic.in.
