Guidelines for providing financial assistance for content and broadcast of programmes on various themes of National interest through Community Radio stations.

#### 1. Background

Community Radio is an important third tier in Radio Broadcasting, distinct from Public Service Radio broadcasting and Commercial Radio. Community Radio Stations (CRSs) are low power Radio Stations, which are meant to be set-up and operated by community-based organisation. As on date, India has 490 Community Radio Stations. The broadcast made by these CRSs are in local language and dialect, so it has more impact on the community.

The Government has approved a Central Sector Scheme titled "Supporting Community Radio Movement in India" wherein a provision has been made to provide support for content creations. The support for content creation will not only promote community broadcast, but will also be a measure towards ensuring financial sustainability of stations.

## 2. Objective

- ii) To encourage CRSs to produce and broadcast contents in local languages and dialects, which are of immediate relevance to the community.
- ii) To promote financial sustainability of CRSs.

# 3. Eligibility Criteria

Any operational Community Radio Station (CRS), can apply for financial support of content already broadcasted during the last 6 (six) months. At the time of application, Grant of Permission Agreement (GOPA) and Wireless Operating License (WOL) should be valid. The financial assistance will be provided for a maximum of 12 episodes in a year per CRS.

#### 4. Application

The applicant will be required to submit application form in the prescribed proforma (Annexure-A), which is available on MIB Website.

#### 6. Selection of Station

A Selection Committee shall be constituted by the Ministry for selection of contents submitted by CRS. The selection of contents shall be on the basis of proposal submitted by the CRS and its relevance to the local community. Decision of the selection committee shall be binding and final.

#### 7. Amount of Financial Assistance

Based on the recommendations of the Selection Committee financial assistance shall be made to the station. A maximum of Rs. 75000/- can be paid to the station. Grant support will be given for a maximum of 12 episodes in a year. Grant will be Rs. 6000/- per episode and Rs. 250/- for administrative expenses per CRS per episode.

8. Budget

The funds will be met from the sanctioned budget grant available during the Financial Year under the Scheme namely: Supporting Community Radio Movement in India", under the head of Grant-in-Aid (GIA-General).
