- 3. After inspection of the items, intended bidders may submit their bids as per proformas / terms and conditions specified in the bid on or before 12.10.22. The bidder/ firm must fill the form(s) as in Annexures and upload copies of all relevant certificates asked for therein viz. Delhi based firm, GST Registration Certificate/ No., PAN, ITR of the last three financial years, e-waste certificate issued from Ministry of Environment, Forest and Climate Change/ Central Pollution Control Board/ Pollution Control Board of Delhi/ NCR and Undertaking alongwith EMD of requisite amount.
- 4. The bids of only those firms will be entertained who physically inspected the items before submission of the bids.
- 5. The bid has to be accompanied by "Earnest Money Deposit (EMD) to the tune of Rs.5000/-. The firms must upload valid Demand Draft of requisite amount drawn in favour of Section officer (Cash), Ministry of Information & Broadcasting (Main Sectt.), Shastri Bhawan, New Delhi. The original Demand Draft should reach the undersigned at 544 A Wing, Shastri Bhawan, New Delhi before EMD Submission End Date. The bids will not be entertained without the EMD.

The successful bidder will be required to remove the material on 15<sup>th</sup> 16<sup>th</sup> Oct. 2022 after award of the contract / acceptance of the tender subject to making full payment by demand draft drawn in favour of Section Officer (Cash), Main Sectt., Ministry of Information & Broadcasting, New Delhi.
- 7. This Ministry reserves the right to reject any or all bids completely or partially without assigning any reason thereof. This Ministry also does not bind itself to accept the highest bid and reserves the right to reject any or all bids without assigning any reason whatsoever. Inadequate or incomplete bids in any respect or the prescribed conditions are not fulfilled are liable to be rejected. In this respect the decision of the Ministry will be final.
