



## Mid-term appraisal of the Central Sector Scheme “Supporting Community Radio Movement in India” (April 2021 to March 2026)

### Executive Summary

To strengthen the Community Radio Sector, the Government of India approved a Central Sector Scheme namely “Supporting Community Radio Movement in India” with an outlay of Rs. 50 crore for a period of 5 years i.e. from 1<sup>st</sup> April 2021- 31<sup>st</sup> March 2026. The mandate of the scheme is to strengthen new and existing CR Stations with resources, capacity and technology, promote growth of Community Radio Stations (CRS), especially in remote and rural areas and to promote socio-economic and cultural development of communities, as CRS is a powerful medium for social mobilization.

To assess implementation of the Scheme and its outcome for the sector, the Ministry, from time to time holds discussion with the stakeholders. During a Stakeholder meeting held on 18.07.2023 and interaction with women led CRS held on 05.09.2023, under the Chairpersonship of Additional Secretary, Ministry of I&B, it was learnt that further push to the sector is required. The stakeholders opined that the financial assistance currently provided to Community Radio Stations is low as compared to the amount needed for setting up of a Community Radio Stations and the same is required to be reviewed. This would encourage more and more organizations to come forward and setup the Community Radio Stations in remote areas in the larger public interests.


The sector stakeholders also opined that there is a need to encourage more women to become a part of CR sector. It was suggested that additional financial assistance may be provided to women led Community Radio Stations. They further opined that activities such as capacity building via fellowships and internships, may also be instituted to built skills for new and existing manpower in the sector.

The stakeholders were of the view that earlier, the National Sammelan was organized by the Ministry of I&B and the same was discontinued since 2019. They suggested that organizing national sammelan has been very useful for the sector as it provided peer leanings from each other. They requested MIB to organize at least one national sammelan per year in addition to the regional sammelans as planned under the Scheme.

The Government of India is putting on emphasis for use of green energy. To encourage the Community Radio Stations to use green energy extra financial support has been necessitated towards installation of Solar Panels for running of Community Radio Stations.

There is **no change in the financial outlay** of the scheme in the instant proposal. Based on the necessity of the activities and felt need of the sector the following changes have been proposed in the scheme

- (i) Increase in financial assistance to Community Radio Stations (CRSs); inclusion of Financial assistance for use of green energy; and special dispensation for women led CRS;

- (ii) Provision of fellowship and internships for CRS sector;
- (iii) Holding National Sammelan for Community Radio Stations once in a year.


## (ii) Rationale for change

### (a) Increase in financial assistance to Community Radio Stations (CRSs); inclusion of Financial assistance for use of green energy; and special dispensation for women led CRS

The mandate of the existing scheme is to strengthen new and existing CR Stations with resources, capacity and technology, to promote growth of CRS, especially in remote and rural areas and to promote socio-economic and cultural development of communities as CRS is a powerful medium for social mobilization. Under the Scheme, the purpose of giving financial assistance is to support the new organization in setting up CRSs, which will encourage more organization to come forward and set up new CRSs. Till date a total grant of 9.38 Crores has been disbursed to about 129 organizations.

In the year 2021-22, when the Scheme was framed, the cost of equipment required for setting up of Community Radio Station was estimated to be Rs. 20 Lakhs. The Scheme provided a onetime Lump-sum Financial Assistance of Rs. 10 Lakhs (Rs. 12 Lakhs for NE) which came at the rate of 50% (60% for NE) of the estimated cost of Equipment for setting up of Community Radio Station.

The estimated cost for setting up of Community Radio Station has been reviewed. As per the cost estimate obtained from BECIL, which is a Public Sector Enterprise under the Ministry of Information and Broadcasting, the cost setting up of a CRS is approximately 26.00 Lakhs. As per the estimate provided by BECIL, it is observed that the cost of all electrical and electronic equipments remained the same, when compared with the estimated cost during framing of the Scheme in the year 2021-22, whereas the estimated cost of erection of Tower is Rs. 4,50,000/= and the estimated cost of Accoustic treatment is Rs. 4,85,000/=; leading to an increase in overall cost amounting

to Rs. 6,00,000/= towards setting up of CRS.

To encourage the Community Radio Stations to use Solar panels in CRS, an additional component i.e. solar panel may be provided to in the permissible equipments of CRS. There would be a requirement of 5 KVA capacity solar panels for running the CRS on Solar Energy. As per the estimate the cost of a Solar panel per KVA is Rs. 75,000/=, thus cost of Solar panel required for CRS is Rs. 4,00,000/= ( Rs. 3,75,000/= + Rs. 25,000/= installation) including installation. Thus the estimated cost of Equipments required for CRS is Rs. 30.00 Lakhs including Solar Panels. **(Please refer Annexure-1)**

At present, the amount of financial assistance is provided to Organisation is 50% (60% for NE) of the estimated cost of Rs. 20.00 Lakhs. There is a need to enhance the financial assistance so that more and more organizations come forward and setup CRS in remote areas in the larger public interest. In view of this, it is proposed to increase the financial assistance in the tune of 60 % (70% FOR NE) of the new estimated cost i.e. Rs. 30 Lakhs which comes out to be Rs. 18.00 Lakhs ( 21 Lakhs for NE).

To encourage more and more women led organization in setting up of community Radio stations, additional financial assistance may be provided. The Financial assistance to CRS having 50% of GBM(Governing Body Members) as women may be given one time financial assistance in the tune of 70% ( 80% for NE) of the estimated cost which comes out to be Rs. 21 Lakhs (24 Lakhs for NE).

Also, in the Scheme, Financial assistance is provided for renewal and replacement of equipment. After 5 years of its operation, the organizations may apply for renewal/ replacement of equipments and the 75% (90 % for NE ) cost of equipment is reimbursed subject to a ceiling of 7.50 Lakhs. Further at present the Scheme also provides financial assistance of 100% to CRS affected due to natural calamity subject to a Ceiling of Rs. 7.5 Lakhs. The ceiling amount for renewal and replacement of equipment and Emergency grant may also be increased in proportion to include Cost of Solar Equipment in cases where existing station wants to switch to green energy. The enhanced Financial Assistance may be provided as tabulated below:-



With the above it is expected to provide financial assistance to at least 100 Community Radio Stations in the FY 2024-25 and 2025-26. It may be noted that such increment has been proposed in view of the vision to setup CRS in remote and inaccessible areas where there is no much incentives for not-for profit organisations. Such enhancement in the financial incentives will encourage NGOs/ Voluntary organizations to setup CRS and use this for social outreach.

(a) *National Sammelan*

Regional Sammelans aim to provide a platform to the operational CRS to share their grassroots stories, successes, issues and good practices. The Regional Sammelans also gives an opportunity to operational CRSs to raise their regional concerns, which they don't get during the National Sammelan. The issues and ideas discussed during the Regional Sammelans also set the priority at national level to strengthen the CRS sector. However, during the Regional Sammelan (North) held at IIMC, New Delhi on 23<sup>rd</sup> and 24<sup>th</sup> of July, 2023, the participants submitted in an open house session that the National Sammelan conducted in the past, brought the whole Community Radio Ecosystem at one place and is an irreplaceable event when it comes to peer to peer learning. Therefore, keeping the desire of CR stakeholders in mind, it has been envisioned to restart organizing a National Sammelan at Delhi every year. New component may be

added to the Scheme, having a budget of 3.50 Crores, however overall budget remains the same.


*(b) CRS fellowships for graduates*

This decision owes its genesis to a desire expressed by participants during an Interaction with Women in CRS held under chairpersonship of Additional Secretary, MIB. Any graduate, **preferably women**, who has a Bachelor's Degree from a recognized University/Institute, may apply for CRS fellowship, where h/she will be associated with a Government Institute. The fellow will get a stipend of Rs 30,000/- per month, a certificate will be given post the completion of the course after assessment, and the duration of the course will be for six months. The remuneration will be transferred directly to the candidate. Expression of interest will be floated for Government institutions and three institutes will be selected that will score the highest in the marking criteria. The fellowships will be capped at twelve (12) per year. This component will give a push to research and development in social psychology and community development sector. New component may be added to the Scheme, having a budget of 0.50 Crores, however overall budget remains the same.

*(c) CRS internships for female students*


This decision owes its genesis to a desire expressed by participants during an Interaction with Women in CRS held under chairpersonship of Additional Secretary, MIB. **Any female candidate**, who has passed Senior Secondary or Intermediate exam, may apply for CRS internship, where she will be associated with an established CRS. The intern will get a stipend of Rs 10,000/- per month, a certificate will be given post the completion of the course after assessment, and the duration of the course will be for three months. The remuneration will be transferred directly to the candidate. The internship will be capped at hundred (100) for the remaining period of the Scheme. This component will result in personal development, skill development and increase job opportunities for youth in remote areas. The decision will encourage more girls to apply as it has been learnt that CRS environment is felt safe for women. This may encourage parents in rural areas to educate their girl child and may help nip child marriages in the bud. New component may be added to the Scheme, having a budget of 0.30 Crores, however overall budget remains the same.




