**Subject: Brief/Minutes of 1<sup>st</sup> Open House Meeting with MSOs/authorized representatives held on 06.05.2014 -reg.**

In the 1<sup>st</sup> OHM, 8 MSO's representatives and 1 prospective applicant turned up for the meeting as detailed below:-

- i) **M/s Microscan Entertainment Pvt Ltd, Mumbai** - Sh. Sandeep Yadav attended the meeting and it was told to him that his case for grant of regular MSO registration is under submission as the requisite security clearance from MHA has been received.
- ii) **M/s S Digital & Datacom Service, Hyderabad** - Sh. Sayyed Mohiduddin attended the meeting. He wanted to know the status of his application. It was told to him that security clearance from MHA is still awaited and the case will be processed on receipt of the same. Some clarification had been sought from the firm on 15.04.2014 the firm was asked to furnish the same. He was also asked to give the details of net-worth position of the Company.
- iii) **M/s Voice & Vision Cable, Singroli (MP)** - Sh. Manish Kumar attended the meeting. He wanted to know the status of their application for MSO registration. It was told to him that security clearance from MHA is still awaited and on receipt of security clearance his case for MSO registration will be processed.

This is a prospective applicant who wish to operate in Damoh, Beena, Sagar, Katni, Chhatarpur, Tikamgarh districts of Madhya Pradesh. It was told to him that he may apply in Form 6 with Form 2 and processing fee of Rs. 1 lakh filling up all the details required in the Form 6. If he desire he

may come with the application (in 3 sets) in the ensuing OHM and his application can be accepted in the meeting itself if it is complete in all respect.

- vii) M/s Indiverse Broadband Ltd, New Delhi** – Sh. Aashish Yadav attended the meeting and also handed over a letter indicating the area proposed to be covered by them as requested by the Ministry. He was told that security clearance in their case has since been received and their case will be processed further.
- viii) M/s Maharaja Telesystem Ltd, Mathura** – Sh. Alok Singh attended the meeting. He was told that MHA security clearance has been received and their case for grant of regular MSO registration is being processed.
- ix) M/s Digi Mahara Cable, Agra** – Sh. Praveen Bhargawa attended the meeting. He was told that security clearance has been received from the MHA and their case for grant of regular MSO registration is being processed.

It was told to them that their case for security clearance is yet to be sent to MHA as details of key Directors/Executives, as per new format devised by MHA, have not been received from them. - ii) Ms. Vandana Singh representing 4-5 firms viz (i) M/s Atria Convergence Pvt Ltd (ii) M/s ACN Cable Pvt Ltd (iii) M/s Sree Digital Pvt Ltd (iv) M/s ACT Digital Home Entertainment** attended the meeting. She was apprised status of their applications. It was told to her that the requisite MHA clearances have not been received, except in the case of M/s ACT Digital Home Entertainment. With regard to M/s ACT Digital Home Entertainment a SCN had been issued but no reply received from them. On this, she stated that they have already sent the reply to the SCN. She was requested to furnish a copy of the same to process the case further. She was also asked to give details of the Directors/Key Executives of the firms as per the new format devised by MHA.
- iii) Sh. Aman Rastogi of M/s Akash Tori Pvt Ltd.** who had made a request for Open House Meeting did not turn up.

**Subject: Brief/Minutes of 5<sup>th</sup> Open House Meeting held on 03.06.2014 –reg.**

The following MSO representatives attended the meeting on 03.06.2014 as detailed below:-

- 1. M/s Silverline Entertainment :** Sh. Santosh Gupta, Proprietor attended the meeting. The security clearance granted to them during October 2013 was withdrawn by MHA on 13.05.2014. MHA has remarked that **Sh. Santosh Gupta, Proprietor of the MSO has given false declaration to Bank of Baroda for securing a loan of Rs. 143.48 lakhs by mortgaging his property. The guarantor for the loan is Pawan Pandey (43.79 lakhs), his wife Arti Pandey (325.16 lakhs) and Manoj Gupta (8.74 lakhs), who do not have any financial base of their own.** Sh. Santosh showed bank letter showing that he was never defaulted in repayments and also guarantor stated by MHA is wrong. To this Director and Advisor replied that since grant of permanent registration is linked to security clearance from MHA, this Ministry is left with no option but to deny permanent registration.
- 2. Indiverse :** The MSO represented by Sh. Ashish Yadav desired to know the status of his application. The MSO has been informed that the proposal is under examination.
- 3. Novabase :** The MSO desired to know the status of his application. The MSO was informed that security clearance has been received and within a fortnight they will be getting their registration.
- 4. Brand Liaison India Pvt Ltd :** Sh. Rajesh Kumar represented the firm. He was not authorized person of the firm. It was told to him that only authorized representative of the MSO is entertained in the Open House Meeting.
- 5. M/s Talcher TV Home Cable:** The MSO had asked for a meeting but did not attend.

In the 11<sup>th</sup> Open House Meeting with MSOs representatives held on 15.07.2014, representatives of following six companies participated in the OHM as detailed below:

1. **M/s GTPL:** S/Sh. Guru Prasad and Abhishek Masan attended the meeting. It was told to them that security clearance has not received from MHA so far. Since they have sent another application for registration therefore details of Boards of Directors may be sent in new format devised by MHA. The company has changed the name from GTPL to GTPL Hathway Pvt Ltd. They were advised to send a formal intimation along with copy of registration.
2. **M/s Technobile Systems:** Sh. Paritosh Shukla attended the meeting. Earlier they were granted permanent MSO registration for certain area. Now, they have applied in June 2014 to grant permission to certain Districts of Uttar Pradesh wherein permanent registration was denied due to non-operationalization of DAS service there. Registered as well as corporate office addresses of the company have changed in new application. It was told to Sh. Shukla that their application will be sent again to MHA for security clearance since address of company has changed. For this, he was asked to send details of Board of Directors/key Executives in the new format of MHA.
3. **M/s Paramount Digital Media Services:** Sh. Anil Dhooper attended the meeting. It was told to him that case is being put up for permanent registration since security clearance from MHA has been received.
4. **M/s Royal Services Digital:** Sh. Aman Kumar attended the meeting. It was told to him that their case has been sent to MHA on 20.05.2014 for security clearance. Same is awaited.
5. **M/s Sanghvi Digital Network:** S/Sh. Kamleshwar P Singh, Jay Sinha and Prabir Sinha attended the meeting. It was told to them that security clearance from MHA is awaited. Reminder to MHA was sent on 21.04.2014. Again reminder sent to MHA on 15.07.2014 to expedite security clearance.

It was also came to notice that a copy of LCO registration in a Post Office was not provided. Sh. Naveen Jain assured that he will provide the same also.
- (ii) **M/s Wiretel Digital:** Sh. B. Ravi Kumar attended the meeting. The details of Board of Directors/Key Executives of the company has not been provided as per the new format of the MHA. A copy of the new format was given to him with a request to provide the same immediately to take up the matter with MHA.
- (iii) **M/s Live Satellite:** Sh. Rakesh Kumar attended the meeting to enquire about permission to import Headened equipment. The company was given MSO license to operate in Phase II, III & IV. They have not operationalized in Phase II so far. It was told to him that their license for Phase II is under cancellation. He informed that they want Headened for Phase III & IV cities. It was therefore advised to him that they may send a request to the Ministry stating the same.
