

I. COMPANY PROFILE

National Film Development Corporation Ltd. (NFDC), is a Public Sector Enterprises set up in 1975 under the Companies Act, 1956. The Company was restructured during 1980 by the merger of erstwhile Indian Motion Picture Export Corporation (IMPEC) and Film Finance Corporation (FFC) and the company emerged as a Central Agency to promote Good Cinema in the country. The primary mandate before the NFDC is to plan, promote and organize and integrated and efficient development of the film industry in accordance with the national economic policy and objectives laid down by the Central Government from time to time. The objectives of the company therefore embodies the spirit of service to the film industry and undertakes to foster excellence in cinema and to develop the state-of-the-art infrastructure as well as equity products in the audio visual and related fields. NFDC is a Schedule 'C' Mini-ratna/CPSE in Financial Services Sector with the administrative jurisdiction of Ministry of Information & Broadcasting.

Its Registered and Corporate offices are at Mumbai, Maharashtra.

The company employed 75 regular employees (Executives: 17, Non-Executives: 58) as on 31.3.2019.

The authorized and paid up capital of the Company is Rs. 45.40 crores and Rs. 45.39 crores respectively as on March 31, 2019.

The shareholding the Government of India in the Company is 100% as on 31.03.2019.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Managing Director is the Chief Executive of the Company and accountable to its Board of Directors and Government/Share holders. He/She is responsible for the efficient functioning of the company, and for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

- Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- Central Government including the Armed Forces of the Union and All India Services;
- State Public Sector Enterprise (SPSE) where the annual turnover is ***Rs 500 crore or more**;
- Private Sector in company where the annual turnover is ***Rs 500 crore or more**.

(The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)*

3. QUALIFICATION:

The applicant should be a graduate with good academic record from a recognized University/Institution.

Applicants holding Technical/MBA/PGDM qualification will have added advantage.

4. EXPERIENCE:

The applicant should possess adequate experience at a senior level in an organization of repute.

Experience in Finance/Marketing/Production will have added advantage.

Knowledge of film industry is desirable.

The minimum length of service required in the eligible scale will be one year for internal candidates, and two years for others as on the date of vacancy.

(ii) **Applicants from the Armed forces of the Union** should be holding a post of the level of Brigadier in the Army or equivalent rank in Navy/Air Force on the date of application.

6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

IV. DURATION OF APPOINTMENT

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

2. Applicants from Private Sector must submit the following documents along with the application form:

(a) Annual Reports of the Company in which currently working for the 3 financial years preceding the calendar year in which the post is advertised (please provide URL or attach/enclose copies);

(d) Self-attested copies of documents in support of age and qualifications;

VI. UNDERTAKING BY THE APPLICANT

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

- (c) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

2. For candidates from CPSE

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
