
Subject:- Compliance of Hon'ble Delhi High Court's Order dated 19.01.2016 in the matter of movie 'Kya Kool Hain Hum 3' [CS (Comm) No. 38/2016-Balaji Motion Pictures Ltd Vs. www.1337.yootorrent.com & ors].

It is brought to the notice of all the TV channels that the Hon'ble High Court of Delhi, in the matter of CS (Comm) No. 38/ 2016-Balaji Motion Pictures Ltd Vs. www.1337.yootorrent.com & ors has granted an ex-parte ad interim injunction against all the Defendants thereby directing that *"the Defendants, are injuncted from communicating, making available, distributing, duplicating, displaying, releasing, showing, uploading, downloading, exhibiting, playing, defraying the movie 'Kya Kool Hain Hum 3' in any manner whatsoever without obtaining prior license from the plaintiff or in any other manner that would infringe the plaintiff's copyright in the said cinematography film through any medium whatsoever"*.

This order was passed by the Hon'ble High Court of Delhi on 19.01.2016 (Copy enclosed).

2. Accordingly, all the TV channels are required to ensure strict compliance with the aforesaid order passed by the Hon'ble High Court of Delhi.
