



OPTION FOR MIGRATION TO FM RADIO PHASE-III

Policy Guidelines for expansion of FM Radio Broadcasting Services through private agencies (Phase-III) dated 25.7.2011, read with amended Paragraph 31 dated 21.1.2015, (the "Policy"), provides an option to the existing permission holders to migrate to FM Phase-III.

2. Existing operators of Phase-II opting to migrate to FM Phase-III, shall deposit 25% of NOTMF amount within 5 calendar days and the balance amount within 15 calendar days, of the notification of NOTMF for existing cities by the Government.
3. The existing permission holders shall be required to sign the Migration GOPA in the prescribed format within 15 days of payment of the full NOTMF amount.
4. The existing operators of Phase-II willing to migrate to FM Phase-III, shall have to furnish their option to the Ministry as per the format prescribed in ANNEXURE.
5. The option for migration to FM Phase-III by FM Phase-I operators who had migrated to FM Phase-II earlier should reach the Ministry at the earliest but not later than 09.3.2015 (against the date of 07.3.2015 intimated earlier which being a non-working day).
6. The option for migration of FM Phase-II operators to FM Phase-III regime should reach the Ministry preferably by 09.3.2015 but before 23.3.2015.
7. The option so exercised shall be considered final and binding.
