- 4. The bids of only those firms will be entertained who physically inspected the items before submission of the bids.
- 5. The bid has to be accompanied by "Earnest Money Deposit (EMD) to the tune of Rs.5000/-. The firms must upload valid Demand Draft of requisite amount drawn in favour of Section Officer (Cash), Ministry of Information & Broadcasting (Main Sectt.), Shastri Bhawan, New Delhi. The original Demand Draft should reach the undersigned at 544 A Wing, Shastri Bhawan, New Delhi before EMD Submission End Date.

The successful bidder will be required to remove the material on 29<sup>th</sup> 30<sup>th</sup> April 2023 after award of the contract / acceptance of the tender subject to making full payment by demand draft drawn in favour of Section Officer (Cash), Main Sectt., Ministry of Information & Broadcasting, New Delhi.
- 7. This Ministry reserves the right to reject any or all bids completely or partially without assigning any reason thereof. This Ministry also does not bind itself to accept the highest bid and reserves the right to reject any or all bids without assigning any reason whatsoever. Inadequate or incomplete bids in any respect or the prescribed conditions are not fulfilled are liable to be rejected. In this respect the decision of the Ministry will be final.
