Draft RRs of Group B Post

Ministry of Information & Broadcasting

New Delhi, the 2022

GSR 162- In exercise of the power conferred by the proviso to Article 309 of the Constitution, and in suppression of the Ministry of Information and Broadcasting, Departmental Canteen Employees Recruitment Rules, 1999, in so far as it relates to the post of the Manager, except as respects things done or omitted to be done before such supersession, the President makes the following rules regulating the method of recruitment to the post of Manager in the Departmental Canteen in the Main Secretariat of the Ministry of Information and Broadcasting, namely:-

- 1. **Short title and commencement**—(1) These rules may be called the Ministry of Information and Broadcasting, Manager (Departmental Canteen) Recruitment Rules, 2022.
 - (2) They shall come into force on the date of their publication in Official Gazette.
- 2. Number of post, classification and pay level in the pay matrix: The number of post, its classification, and the pay level in pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. **Method of recruitment age limit, qualification etc.:** The method of recruitment, age limit, qualification and other matters relating to the said posts shall be as specialized in columns6 to 13 of the aforesaid Schedule.

4. Disqualification-No person

- (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to any of the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. **Power to relax-**Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by order for reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.
- 6. **Savings**-Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provide for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
